The following is a **tentative** walk through schedule by *class* (see running order above).

FAST -All levels	All walk. 5 minutes for first dog on the line All heights and levels will run together.
M/E Standard and JWW	Will be split into 2 walks. Split will be indicated on the gate sheet. There will be no 5 min for first dog on the line
T2B	Friday – one walk. 5 minutes for first dog on the line Saturday - Split into 2 groups for walk and then all run. There will be no 5 min for first dog on the line
Premier Standard	all walk, run

Open Standard	all walk, run
Novice Standard	all walk, run
Open JWW	all walk, run
Novice JWW	all walk, run

## IMPORTANT INFORMATION – PLEASE READ!

- ❖ We will be unloading the trailers at approximately 6:00 PM. If you can help – thanks. **Exhibitor set up after trailers are unloaded. Building will close at 7:30 PM**
- ❖ Our judge is a VMO. If your dog needs to be measured, please make sure to do so before your first class
- ❖ **You will need to bring a plastic/waterproof sheet to put under your crates/x-pens. Straw mats must have a plastic sheet under them. This applies to the basketball court as well as the turf.** Please set up crates/x-pens in designated crating areas only.
- ❖ We have plenty of crating space available; however, we do ask that you conserve space to allow adequate room for everyone. GTOTC reserves the right to condense areas if necessary. Please do not crate along the sides of the ring.
- ❖ Dogs are to be crated or held on leash at all times, other than in the ring or at the practice jump. Please be considerate of fellow exhibitors and spectators by watching your dogs. This rule will be strictly enforced!
- ❖ **Please park Trailers/RVs in the north parking lot. Trailer/RV parking is not allowed in the west parking area including along the grass.** City regulations **do not permit overnight parking at the show site.**
- ❖ No tents are allowed in the parking area at this show site.
- ❖ We will accept day-to-day move ups. Move up forms will be available at the score table.
- ❖ Please clean up after your dogs at the show site and where you have overnight accommodations. “No dog” areas will be indicated. Do not walk your dogs on the grass surrounding the Senior Center – they’ve been great neighbors for all of our trials. **Please do not allow your dog to pee on the building.**
- ❖ No dogs allowed in the lobby area.

## DIRECTIONS TO SHOW SITE

**Trial Location:** Sylvania Sports and Exposition Center at Tam-O-Shanter, 7060 Sylvania Avenue, Sylvania, OH 43560

- **From the North:** Take US-23 South to Exit 13, US-20/Central Avenue. Turn right unto W. Central Avenue/US-20. Turn right onto N. MCCord Road. Turn left onto W. Sylvania Avenue to the Sylvania Sports & Exposition Center at Tam-O-Shanter.
- **From the South:** Take US-23 North to Exit 13, US-20/Central Avenue. Turn left onto W. Central Avenue/US-20. Turn right onto N. MCCord Road. Turn left onto W. Sylvania Avenue to the Sylvania Sports & Exposition Center at Tam-O-Shanter.
- **From East or West:** Make your way to North or South bound US-23, and follow the above directions.
- **The Sylvania Sports & Exposition Center at Tam-O-Shanter is on the north side of W. Sylvania Avenue.**
- Turn right on Vicksburg. Drive around to the back of the building for parking and entrance to the trial. Parking also available at the front of the building.
